EasyEnvelopes.dmg This is a widget to print one off envelopes. It even prints the post office bar code, too! 10.4 to 10.6. Freeware

iPhotoImageArchiver-1.0.3.dmg This is an iPhoto plug in to allow for backup archives. You can save out as .dmg mac files or zip/tar files. This app is for iPhoto 08 or better and 10.4/10.5. \$9.95 Shareware fee.

LittleSnitch-2.2.dmg This program will report on programs that send out requests to sites on the Internet. Some programs do this just to check for updates, but if you are not expecting a program to do this, then Littlesnitch will be of use. Updated for 10.6. Requires 10.4 -10.6 PPC/Intel. \$29.95 Shareware

man_viewer_310.tbz This freeware program will allow you to more easily read the Unix manual (help) files on your computer. It has search functions and can save out as text or postscript.

TemperatureMonitor.dmg This program will monitor all internal temperature sensors within your computer. It can also make history curves. OS 10.4 to 10.6 Freeware

TheUnarchiver2.0.2.zip This program was being discussed in our e-group recently. It lets you extract or

uncompress if you will .sit, Tar, Zip RAR, and other files. Freeware. 10.3.9 to 10.5.

veusz-1.5.dmg This is a scientific plotting program and a variety of plot types are supported. It can fit curves to data and it has a GUI and command line interface. 10.4 PPC/ Intel or better. Freeware.

vlc-1.0.2.dmg The full name of this media player is Video Lan Client. OSX 10.5 -10.6 PPC & Intel. It plays back a great number of formats, such as DivX, OGG, Mpeg, and others. Freeware

Ejecting a Stuck Disk, Changing Your Account Name and Faxing From Your Mac

Welcome to My First Mac's Q&A column. It is said that Macs are easier to use, but they are still complex in their own right. Here are a few questions we have received lately from readers like you. Sometimes we reformat the questions for clarity and presentation.

This week Chris answers your questions about ejecting a stuck disk, changing your account name and faxing from your Mac.

QUESTION:

I put in a CD to copy some pictures (another problem for another time) and now I cannot eject the CD. I tried the button on the keyboard - nothing. I tried going to file but EJECT is grayed out. The computer doesn't seem to see the disc. Is there a way to force eject?

ANSWER:

I try these things first: right-click on CD icon and choose Eject Disk, Select disk and go to the Finder's File menu and choose Eject (cmd-E), and drag icon to trash/eject symbol. Sometimes the normal ways don't work and the Finder won't cooperate. Next I would try relaunching the Finder. You can do that from the Force Quit box (opt-cmd-esc). If all else fails, I restart my Mac holding down the Eject key after the chime. That always works for me.

QUESTION:

Best Buy set up my MacBook and put my dad's name as the user; is there any way I can change it?

ANSWER:

Go to *System Preferences>Accounts* and change the Full Name there. However, you may want to take this opportunity to just add yourself as a Standard account rather than the main Admin one. Doing this adds a layer of safety because you will have to enter the

Admin info whenever serious changes are made to your Mac.

QUESTION:

I just purchased a Mac computer, and I had a PC before and I was able to download software onto my PC so that I could fax. Is this possible with a Mac? Can I download software so that I can fax directly from my Apple computer? If this is possible, where would I find software on the web, preferably free.

ANSWER:

You are in luck because your Mac already comes with the software to act as a fax machine. It's just not obvious. But you will need to get some hardware: a USB modem and a phone line. Once you have those things added, go to System Preferences>Print & Fax and add a new device. Select from the Fax choices. Now when you need to fax the document you are working on, go to Print and look for the little PDF button/menu in the lower left. Hold that down and select Fax PDF from the options.



Now you may be asking about Internet faxing, where you use an Internet service and your ISP connection rather than a phone line. In that case there are many services like <u>eFax</u> or <u>Fax.com</u>, but I don't know of free ones. These charge a monthly fee.

Swap a MacBook's


Glossy Display for Matte by Dave Caolo on Oct 12, 2009 via Cult of Mac

Users have a love/hate relationship with Apple's glossy displays. Namely, they either love them or they hate them. I haven't used one myself, as I'll be hanging on to my original MacBook Pro until it ceases to work.

Until now, shoppers could get either a glossy or matte display with the 15" MacBook Pro, but not the 13" model. TechRestore has stepped in to do the "repair." For \$200, they'll remove your 13" MacBook or MacBook Pro's glossy display and slap a matte screen in its place. The work comes with a 1-year warranty and TechRestore says they'll have your precious back to you within 24 hours of receipt. Note that this requires a trade-in of your existing screen; you won't get it back.

If you have this service done, please let us know how it goes. Enjoy your glare-free computing.

For comparison, RadTech sells an anti-glare film that can be applied over a glossy display. They're available for the 13in MacBook/Pro (unibody), the 15in MacBook Pro (unibody), the 17in MacBook Pro (unibody) and various iMacs. You can get the
